EXHIBITOR VENDOR TERMS & CONDITIONS

1. **STORAGE OF MATERIALS** during 60.5 Move Health & Wellness Expo must be confined within the area assigned to you. Plan for storage within your area when designing the configuration of your booth area. Booth space will be limited to the designation that you pay for.
2. **VENDORS ARE EXPECTED** to provide their own chairs, tables and display boards. Do not tape, tack, or otherwise affix any materials or signs to walls.
3. **CHAIRS & TABLES** are available or rental via 60.5 Move Health & Wellness Expo and the vendor that they contract with. The rental fee includes set-up and tear-down. Vendor is responsible for any damage that may occur to the rental items (chairs and tables).
4. **VENDORS ARE RESPONSIBLE** for transporting and placing their own booths. Labor to erect booths will not be provided.
5. **NO VENDORS OR THEIR REPRESENTATIVES** shall conduct themselves in a manner offensive to general standards of decency or good taste. 60.5 Move Health & Wellness Expo reserves the right to screen all booths and exclude inappropriate items. In the event of inappropriate behavior, the booth will be forced to close and all fees will be forfeited.
6. **ALL VENDOR BOOTHS** and their representatives must present a professional image at all times. Vendors are not allowed to use confetti or other supplies that could cause clean-up issues on the Washington Pavilion in Downtown Sioux Falls or that is considered litter. Clean-up fees will be assessed by 60.5 Move Health & Wellness Expo if this occurs. Business signage may only be placed in booth space. Signage, flyers or other promotional materials outside of the vendor designated space is prohibited and will be destroyed.
7. **WHEN VACATED**, booth space must be left clear of paper, packing materials and other refuse. Do not discard cartons or packing materials anywhere in the expo area. These items must be stored in your vehicle and taken with you upon departure. Vendors are responsible for providing their own garbage receptacles.
8. **VENDOR SET-UP** will be from 12:00PM-6:00PM on April 22, 2022, also Saturday, April 23 from 7:00AM-9:30AM, and be fully set up with someone on-site at the booth for inspection by the Health Department. Once the time of inspection is available, it will be communicated to all vendors. Vendors must be available during the entire event hours.
9. **PROOF OF INSURANCE** must be provided by each vendor. Each vendor must ask his insurance agent/company to provide the 60.5 Move Health & Wellness Expo with a Certificate of Insurance naming 60.5 Move Health & Wellness Expo, Sioux Falls Skedaddle Half Marathon, Washington Pavilion, as an additionally insured. Vendors are expected to carry their own insurance coverage to protect their merchandise from damage, loss or if theft occurred while participating in the festival. All vendors will provide a copy of their commercial general liability policy with a limit of \$1,000,000 per occurrence for bodily injury, property damage and personal injury. No insurance or guard services will be supplied by 60.5 Move Health & Wellness Expo. Participation in the event is at the vendor's risk. In the event of bad weather, there will be no refunds. Each vendor also agrees to exonerate 60.5 Move Health & Wellness Expo, Sioux Falls Skedaddle Half Marathon, Washington Pavilion, event sponsors, staff, volunteers and contracted workers or any other helpers from any injuries, damages, theft or losses while setting up, attending, transporting to and/or from the event, or at any time during the event. Copies of the policies must be included with the application submitted to 60.5 Move Health & Wellness Expo.
10. **NO FOOD IS ALLOWED TO BE SOLD** by exhibitor vendors. Only food vendors will be allowed to sell or distribute ready-to-eat food at the event. Samples of food items are allowed with permission from event organizers. Food vendors are only able to sell from the approved list of menu items. Exhibitor vendors wishing to sell food at their booth may not be able to do so 60.5 Move Health & Wellness Expo reserves the right to review. Any vendor selling to distributing samples outside of these guidelines may be shut down for the remainder of the festival and no refunds will be given.
11. **SUBMIT A COMPLETE LIST** of proposed sales items, prices and photos of booth. To preserve the integrity of each vendor's market, this list will be screened and a final approved listing will be returned with your confirmation. Only items on the approved list will be allowed for sale at 60.5 Move Health & Wellness Expo.
12. **MUSIC** is not allowed to be played by any of the vendors since entertainers and all on-stage performers will be on the main stage throughout the expo. Booth music is distracting to customers and 60.5 Move Health & Wellness Expo reserves the right to ask those vendors playing music to cease activities. If asked more than once to stop playing music, the vendor may be asked to leave with no refunds given.
13. **TAX-EXEMPT** vendors must provide a copy of your certificate of exemption with your application in order to not be charged the taxes on this application.
14. **NON-SUFFICIENT FUND PAYMENTS** will be charged to the vendor, an additional \$40 fee plus any other fees incurred by 60.5 Move Health & Wellness Expo from the bank. Vendor is also responsible for any fees incurred by means of collecting, including third party collection agencies.
15. **NO REFUNDS** will be processed once your application and payment has been received. In the event of bad weather, an act of God, or any unforeseen occurrences that could cause a postponement, rescheduling or cancellation of the event, vendors are not entitled to a refund. Vendors unable to set-up during a rescheduled date forfeits their booth rent. Our general policy is that the event will occur, rain or shine. We do reserve the right to assess this on a case-by-case basis.
16. **DRAWING OF BOOTH** must be provided by all vendors for their expected set-up. No lighting, furnishings, cookers, storage trailers, straps, cables, ropes, stakes, etc. may extend beyond the boundaries of the allotted booth space without prior authorization.
17. **WATER** at the Washington Pavilion is not available on the day of the event. If you require access on-site to water, please indicate on booth application and contact 60.5 Move Health & Wellness Expo for details on availability and cost.
18. **FAILURE TO COMPLY** to these terms and conditions by any vendor will not be allowed to set up or will be shut down for the duration of the expo and will forfeit all associated permits and expo fees.
19. **AGREEMENT BY** signing this form, the applicant acknowledges having received and fully read the application and agrees to abide by all rules, terms and conditions surrounding 60.5 Move Health & Wellness Expo.
